III. Treasurer's Report – bank statement was provided (*see attachment*), however it appears that the report provided was a duplicate of last month's report, and it was tabled until after an audit is performed by the incoming Treasurer.

GROUP REPORTS

- **1960 Group** attendance has been low at the in-person meeting at the church on Saturday nights at 8:00 PM. Zoom meeting has been discontinued. Meeting support would be appreciated.
- Alive & Kicking They are opening up at 25% for in-person meetings. Zoom meetings are also still occurring. They will be having a Crawfish Boil on 4/3/2021 @ 1:00 PM with \$12 plates.
- Chance for Freedom Opened up in-person meetings on Mon, Thurs, and Friday at 8:00 PM in the Gym. They need a new copy of the liability insurance for the facility from the Area, and their copy is expired as of 2019.
- Copperfield meets Mondays and Fridays on zoom. Low attendance.
- **Hope Sweet Hope** Average attendance is 7-15 in-person and on zoom. Needs some meeting support.
- **Hugs not Drgus** They have opened up all their meetings in-person. Attendance has been low, but they believe it will pick up.
- **Jekyll & Hyde** meets Sundays at 6:00 PM (HYBRID meeting). They are open to the public as of last week. Average attendance is 40-45 in-person, and 28-35 on zoom.
- **Keep it Real** Meets daily at 10:00 PM in-person. Attendance is low, averaging 3-10 per meeting.
- New Pathfinders Meets Mondays at 8:00 PM in-person. Average attendance is between 3-7 members per meeting, but that's normal for them. They are seeking meeting chairs to be rotated monthly.
- Our Common Bond Meets Tuesdays and Thursday in-person, and Thursdays and Sundays via Zoom.
 - Average attendance is 8-15 members per meeting. All positions are filled. Events: 4/18/2021 from 10-4 pm Volleyball/Potluck. 6/19/2021 @ Elk's Lodge Anniversary Event. 5/29/2021 @ 5:30 PM Speak & Eat. They are also planning the River Run, to be held in September.
- **Phoenix Group** Meets on Zoom Tuesdays and Thursdays. Attendance has been high. Meets inperson on Tuesdays, with 2-8 attending. Masks are required, and temperatures are taken.
- **Rainbow of Hope** meets Tuesdays at the church and on Zoom at 7:00 PM. Masks required. Low attendance for the in-person meeting, but good attendance on Zoom.

Hurshell C. suggested adding NASCONA to the number of Areas in the MSC.

Point of Information: The MSC is there to support the Areas, not replace them, and will need to be presented to all existing Areas involved after we agree to proceed. An Ad Hoc Subcommittee was suggested for further discussion, as we need more than 15 minutes to explore this idea. It was also pointed out that, historically, only one or two members will show up to any Ad Hoc meeting. An Amendment as suggested to reach out to the admins of other existing Areas FIRST, before we agree to proceed with a vote. Q - What need or void is this helping to fulfill? A – no need or void has been identified, other than the phone line which services all four Areas, but there has been significant interest expressed by nearly all members contacted by the proposal presenter. It was pointed out that HASCONA used to have better communication and coordination with other Areas in regards to events scheduling, etc, and it is the opinion of an addict that we have stopped communicating and coordinating with other addicts.
